Dear President-Elect Biden,

As organizations committed to reproductive, gender, economic, immigrant, and racial justice, we know that this is a crucial moment for Black and Brown communities, women, LGBTQ folks, immigrants, and young people. Our communities are still trying to survive the COVID-19 pandemic and people continue to fight for racial justice all over the country. We are fighting for a future in which we can control our own bodies, safely care for our families, and work with dignity, no matter who we are or where we live. We are reimagining a world in which each of us makes a living wage, has the right to unionize, families live free from violence, and everyone has access to the full-spectrum of reproductive, maternal, and sexual health care, including abortion.

The Biden-Harris transition priorities¹ reaffirm a commitment to ending systemic racism and economic inequality, getting control of the global COVID-19 pandemic, and ensuring access to reproductive healthcare including abortion for people in the U.S. and around the world.² The millions of women³, Black⁴, Indigneous⁵, and people of color, and low-income people who turned out in record numbers voted to prioritize these issues. To collaborate on implementing these priorities, we look forward to working together to create a Biden Cabinet comprised of leaders with pro-worker, pro-immigrant, and pro-abortion access records.⁶

This is a moment to elevate the leadership of the diverse coalition that voted to build back better: women; Black, Indigenous, and people of color; LGBTQ people; low-wage workers; and immigrants. The undersigned organizations urge you to build from the diverse agency review teams⁷ to assemble the most diverse Cabinet in history.⁸ We also urge you to consider any appointees' record on reproductive and sexual health and rights, including abortion; immigrant rights; and workers' rights before naming them to the Cabinet.

Executive nominees and appointments are a crucial component of building back better and realizing a more just and equitable world, as they are responsible for implementing policies and regulations which impact our communities in the U.S. and communities around the world. As noted in Principle 5 of the Blueprint for Sexual and Reproductive Health, Rights, and Justice, the President's appointment power has a significant impact on sexual and reproductive rights, health and justice. Executive agencies play a key role in interpreting and defining legal

protections and civil rights across domestic and foreign policy9.

During the four years of the Trump administration, federal agencies were used to cause much harm to our communities. As one of the current administration's first acts, the global gag rule was radically expanded, disrupting access to health care for millions of people around the world who are reached by U.S. global health programs. The Secretary of Labor opposed raising wages for low-wage workers, refused to issue emergency guidelines to protect essential workers during the pandemic, and tried to stop low-wage workers from holding large corporations accountable for abuse on the job. The Trump administration's Health & Human Services (HHS) added yet another insurance barrier to abortion care. The Office of Refugee Resettlement, within HHS, denied immigrant women in detention centers access to abortion care. and Immigration and Customs Enforcement (ICE) staff inflicted reproductive violence on more than 50 women. Under the current administration, family separation became a policy, taking thousands of children from their parents. Finally, over the past four years, this administration decimated the Title X family planning provider network. These harmful policies strip people of bodily autonomy and the ability to choose if and when to parent.

To undo the damage from the past four years and build back better, we need to restore expertise and leadership into federal agencies. We are encouraged that you've already begun to appoint executive nominees and appointees who are experts in the field of the agency, office, or program they will lead, and who possess a demonstrated track record of leadership in that field. Crucial positions include but are not limited to the Secretary for Health & Human Services, Administrator of Centers for Medicare and Medicaid Services, Labor Secretary, Secretary of State, Attorney General, USAID Administrator, Chair of White House Council for Gender Equity, and the Food And Drug Administration Commissioner. All cabinet agencies should appoint a high-ranking, full-time official tasked with advancing gender equity at the intersections of racial, economic, immigrant, and reproductive justice, who would be responsible for participating in the White House Council for Gender Equity and implementing gender equity efforts at the agency level.

The nominees and appointees must have a strong commitment to protecting and expanding reproductive healthcare¹⁹, including abortion; racial justice; ensuring economic security for
